GOLF CART FEES APPLY TO YOUTH MEMBERSHIP AND MUST BE 14 YEARS OLD TO OPERATE CART WITHOUT AN ADULT AND 16 YEARS OLD TO RENT A CART.**

**ALL UNMARRIED COUPLES LIVING TOGETHER MUST EACH BUY A SINGLE MEMBERSHIP UNLESS ONE PERSON HAS CHILDREN LIVING WITH THEM THEN THAT PERSON MUST BUY A FAMILY MEMBERSHIP.**

**\*ALL GOLFERS USING PRIVATELY OWNED CARTS MUST PAY TRAIL FEES. IF YOU OWN A MOTORIZED CART AND DO NOT RENT A 3/30 CLUB CART STALL, YOU STILL MUST PAY TRAIL FEES.**

The son/daughter of a member who is 18 years of age and is not attending school and is not in the Military Service is subject to full dues. Military children over the age of 23 are required to pay dues. If the son/daughter lives out of the 15 mile radius from Lowden, they must pay green fees and/or swim fees or pay Club dues. If they live within the 15-mile radius and use the Club's facilities, they must pay dues.
